

2013 IABC FELLOW NOMINATION FORM

The Fellow designation is the highest honor IABC confers upon members. It denotes a body of achievement as a communicator or communication educator who has had a significant impact not only on the communicator's organization and IABC, but on the communication profession. This impact can be universal in nature or specific to a country or region. One way to think about the Fellows designation is as a "professional career award," although the designation is by no means limited to communicators nearing the end of their careers.

Nomination of an IABC member for consideration by the Fellow selection committee must be accompanied by your personal letter of recommendation in addition to documentation that supports the nomination, specifically in the four categories detailed on the following pages. Please note that you may also, in addition to your own letter of recommendation and supporting documentation, submit additional letters of recommendation from others who endorse your nomination.

You may use the space on these pages or submit a separate document, not to exceed four pages, that addresses each of these four areas. Please note that a representative of the Fellow selection committee may approach you or your nominee directly for additional information.

Please fill in all of the following information completely. Additional information on the nominee should be attached to this form.

Please be sure to address each of these areas in your narrative, and include the nominee's current résumé. Keep in mind that the selection committee may not know the nominee, so the more information you can include, the better.

Contributions to IABC (25 percent)

Volunteerism at the chapter, region and international board levels, committee activity, other volunteer efforts, presentations to chapters and regions, articles written for IABC publications and other IABC-related activities.
